1	17-11-2025		<p>The Popular Maruti (<a href="http://www.popularmaruti.com">www.popularmaruti.com</a>) and Popular Nexa (<a href="http://www.popularnexa.com">www.popularnexa.com</a>) websites appear to have been compromised by a malware attack, resulting in visitors being redirected to external sites displaying inappropriate content. Several pages returned 404 errors, and Google's index showed fake URLs. As an immediate containment measure, the websites were taken offline to prevent further damage. As per the vendor's root cause analysis, the Popular Nexa website is nearly ten years old and was built using an outdated WordPress theme, making it highly vulnerable to spam injections and security breaches. The malware infection impacted the entire server hosting the websites. To prevent recurrence, the vendor migrated all websites to a more secure, high-performance server to enhance protection. Additionally, the Popular Nexa website was moved to a dedicated separate server. Access to <a href="http://www.popularmaruti.com">popularmaruti.com</a> and other associated websites was reinstated on 18-11-2025, and access to <a href="http://www.popularnexa.com">popularnexa.com</a> was restored on 26-11-2025.</p>
